

PERMISSION REQUEST FOR USE OF IMAGES

Permission to use an image from the Chippewa Valley Museum collections is granted as long as the following conditions are met. By signing below, you agree to these terms of use.

- 1. Permission must be granted in writing or electronically using this form. Possession of an image does not constitute the permission to use it.
- 2. Permission is for one-time, one-project use only. The Chippewa Valley Museum retains all rights to the images, and they may not be used for any other purpose than that listed on this form.
- 3. The permission fee must be paid before using the images.
- 4. Credit must be given to the "Chippewa Valley Museum" and to the creator of the work, if known.
- 5. Credit must appear in context with the image or on a credit page that indicates the page number and position on the page.
- 6. If the image is still under copyright and the copyright is not held by the museum, the requestor must seek permission from the creator of the work or from the current copyright holder. Museum staff will provide the creator's name, if known.
- 7. The Chippewa Valley Museum assumes no responsibility for infraction of copyright laws, invasion of privacy, or any other improper or illegal use that may arise from reproduction of any images. In all instances the applicant agrees to hold the museum and its agents harmless against any and all claims arising or resulting from the use of this image and shall indemnify the museum and its agents for any and all costs and damages arising or resulting from any such unauthorized use.
- 8. Photographs may be cropped to suit design and layout, but they may not be altered, colorized, or drawn upon without a letter of permission in addition to a signed permission form.
- 9. The Chippewa Valley Museum reserves the right to decline permission to publishers and individuals who have not complied with these conditions.
- 10. In some cases, the Chippewa Valley Museum will request that a copy of the publication be donated to the museum.

- Private individuals must pay at the time of order, the time of pickup, or some time in between. For businesses orders, you may choose to be invoiced at the time your order is sent to you, after which we ask that you remit payment within 20 business days.
